## **NOTICE OF PUBLIC HEARING**

Sound Level Variance – March 14, 2015 Visit Saint Paul St. Patrick's Day Street Festival

TO: West Seventh/Fort Road Federation

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

## **Description of Variance:**

<u>Location:</u> 7<sup>th</sup> Street West between Chestnut and Walnut Streets for live music in the street on a mobile stage in front of Eagle Street Grille, 174 7<sup>th</sup> Street West, use of a DJ Stage in front of Cossetta's, 211 7<sup>th</sup> Street West and for use of a DJ Booth in front of Tom Reid's, 258 7<sup>th</sup> Street West

Noise Source: Visit Saint Paul Festival has requested a sound level variance to present live music in the street on a mobile stage in front of Eagle Street Grille, 174 7<sup>th</sup> Street West, use of a DJ Stage in front of Cossetta's, 211 7<sup>th</sup> Street West and for use of a DJ Booth in front of Tom Reid's, 258 7<sup>th</sup> Street West between Chestnut and Walnut Streets for the 2015 Saint Patrick's Day Street Festival. The variance shall be for the hours of 2:00 p.m. to 10:30 p.m. on Saturday, March 14, 2015. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance shall be for the hours of 2:00 p.m. to 10:30 p.m. on Saturday, March 14, 2015. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured 50 feet from any stage, PA system, loudspeaker or any other device. 3) The applicant shall provide personnel and equipment to conduct continuous sound level monitoring during the event. 4) All electronically powered sound equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:30 p.m. on the event date.
