#### NARRATIVE

ICC available, squad 1471.

On 11/14/14 at 2128 hrs, I, J. Raether, squad 386 was sent to 134 Maria Ave, on the report of a suspicious person walking around looking the windows of a vacant house.

When I arrived I observed the registered vacant building placards on the front door and could see lights on inside the house on the first floor. No doors or windows appeared to be forced open. While looking in through a window on the south side of the house I could see movement. I went to the back door of the house which also had the registered vacant building placards and knocked for several minutes and announced our presence with no response.

I spoke with Sgt Shanley and received permission to enter the house. I breached the back door of the house and located the two suspects, Moyer, Brandy Lee, 972 Euclid Ave, St Paul MN 55106 and Wylle, Daniel Joseph, 5/17/73, 666 Sims Ave, St Paul MN 55106 and took them into custody without using force. I issued Moyer and Wylie citations for trespassing and released them at the scene. I called for a board up crew and had the back door secured. I spoke with the home owner who advised me that he had problems with people entering the house and appreciated us removing the people.
