On 1/2/2014, Albert Edwin Moen appeared in Ramsey County District Court for 62-CR-13-9206 and pled guilty to the offense of Damage to Prop-1st Deg-Value Reduced Over \$1000 - 609.595.1(3), which occurred on 12/2/2013. **Sentencing in this matter has been scheduled for 2/25/2014 at 9:00am before Judge Gearin.**

The Ramsey County Probation Department has been ordered to complete a pre-sentence investigation and forward a report to the Court prior to sentencing. I have been assigned to complete the pre-sentence investigation and will be contacting you regarding your victim impact statement.

Chapter 262, Minnesota laws 1983 provide you, as the victim of a crime, with the following rights:

- (1) Victim Service Notification – Various programs/services may be available to help you with problems you are experiencing as a result of the crime. You may call Crime Victims Center (612-340-5400) for information about these programs/services.
- (2) Right to Object to Plea Agreement – If the defendant was convicted as a result of a plea agreement between the prosecution and the defense counsel, you have a right to object, in writing, to the terms of the agreement. If you choose to submit a written objection, forward it to me as soon as possible so it may be forwarded to the Judge before sentencing. The plea agreement in this matter consisted of: 90-day cap, restitution.
- (3) Right to Object to Proposed Sentence – You may submit a written objection to the proposed disposition (sentence) in this matter. Please call me for details of the proposed disposition as well as the Court's options. If you wish to submit a written objection, please forward it to me as soon as possible.
- (4) Right to Request Restitution – You may request the sentencing Judge to order the defendant to pay restitution to you. Enclosed is an Affidavit for Restitution, the document required to determine restitution. You must complete this affidavit and have it notarized if you are seeking compensation. Please include damage estimates for repair, paid receipts, copies of medical and/or auto repair bills not covered by insurance. Be sure to complete the insurance portion of the affidavit. Include a copy of your insurance policy verifying the insurance deductible, as it applies to your situation. **Failure to provide the required supporting documentation may result in a delay or inability to determine restitution.**

The Judge or the Probation Department will review the completed affidavit and a restitution amount will be determined. Please understand some damages may not fall
