## **NOTICE OF PUBLIC HEARING**

**Duathlon National Championships 2015** 

TO: West Side Community Organization, West Seventh/Fort Road Federation, CapitolRiver Council District 17

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. <u>Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.</u>

## **Description of Variance**

## Location: Harriet Island

**Noise Source:** USA Triathlon has applied for a sound level variance in order to provide amplified music and the use of a sound system for announcements from 5:00 a.m. until 3:00 p.m. on June 6, 2015 during the Duathlon National Championships. The Department of Safety and Inspections will be recommending the following conditions: 1) Variance will be for the hours of 5:00 a.m. until 3:00 p.m. on Saturday, June 6, 2015. 2) All electronically powered equipment, PA systems, loudspeakers, or similar devices will only be located at the three (3) locations indicated on the venue diagram submitted as part of the sound level variance application. 4) All electronically powered equipment, PA systems, loudspeakers, or similar devices will be aimed or located so they are facing away from residential use areas such as those across the river or the bluff area to the south. 5) All electronically powered equipment, PA systems, loudspeakers, or similar devices used in conjunction with the event must not exceed the following sound level limits: A) On June 6, 2015, between the hours of 5:00 a.m. until 8:00 a.m. must not exceed 75 dBA at 50 feet from the source. B) On June 6, 2015, between the hours of 8:00 a.m. and 3:00 p.m. sound levels must not exceed 85 dBA at 50 feet. 6) The applicant will provide personnel and equipment to provide continuous sound level monitoring to ensure compliance with the sound level variance conditions. 7) All electronically powered equipment, PA systems, loudspeakers, or similar devices must be turned off no later than 3:00 p.m. on June 6, 2015.
