## NOTICE OF PUBLIC HEARING

Sound Level Variance Minnesota AIDS Project, The Minnesota AIDS Walk Event 2015

## St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request.

Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

## Description of Variance:

Location: Intersection of Mississippi River Boulevard North and Ford Parkway

Noise Source: The Minnesota AIDS Walk Event, represented by Beth Megas, Fundraising Coordinator, has requested a sound level variance in order to allow amplified sound from a non-broadcast radio van at the intersection of Mississippi River Boulevard North and Ford Parkway from 10:30 a.m. until 1:00 p.m. on Sunday, May 17, 2015. The Department of Safety and Inspections (DSI) recommends the following conditions: 1. The variance shall be for the hours of 10:30 a.m. to 1:00 p.m. on Sunday, May 17, 2015. 2. All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured at 50 feet from the sound source. 3. The applicant shall provide personnel and equipment to monitor sound level limits as specified in Condition #2. 4. All electronically powered sound equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 1:00 p.m. on the event date.
