RE: Correction Notice

To Whom It May Concern:

Last Spring (2014) I had accepted a bid from a professional painting business (Freeman Painting) to paint both the trim and the rest of my house and garage. Due to some employee turnover and other weather issues, he didn't make it over last year.

This Spring I was in touch and told him I still wanted the work done, and he promised to put me on his list and get it done this summer.

Earlier this week I received a Correction Notice (copy attached) stating that on May 28, 2015 a City Code Enforcement Officer had stopped by my house and issued an order for correction by June 29, 2015.

I put myself in touch with the painter (Dan Freeman) on June 2nd to ask where I was at on his schedule. He responded to me and told me he should be able to get over to my place by mid-July.

So I would like to appeal the notice and ask for an extension of time until the August 15, 2015. Then, if Freeman Painting has not shown up by the end of July, I will go ahead and scrape and paint the areas of the garage as-needed to correct the deficiency myself.

Would that be acceptable? I've also enclosed my most recent email exchanges with Dan Freeman to document my conversations with him.

Thank you for your consideration.

CORRECTION NOTICE

Dear Sir or Madam:

The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on May 28, 2015 and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code¹ (see footnote 1, below).

1. The exterior walls and/or trim of the garage has defective, peeled, flaked, scaled or chalking paint or has unpainted wood surfaces. Scrape and repaint to effect a sound condition in a professional manner.

SCRAPE AND PAINT THE GARAGE.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will re-inspect these premises on or after **June 29, 2015**, by which date the violations noted must be corrected. **Failure to correct these deficiencies may result in the issuance of criminal charges**² and/or a civil lawsuit, and possible abatement/assessment by the City. All repairs and new installations must be made in accordance with the appropriate codes. Permits may be obtained by calling 651-266-8989.

You may file an appeal to this notice by contacting the City Clerk at 651-266-8585. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal, and pay a filing fee.)

If you have any questions or request additional information, please contact me. To arrange an appointment or request an extension of time to complete repairs, you will need to speak directly to me at 651-266-1924.
