Carol,

The public hearing on this matter is scheduled for the 5:30 portion of the Council meeting on Wednesday. If anyone shows up and wants to talk about this appeal, the easiest thing to do is simply tell one of the greeters that they'd like to speak. I will then ask the Council to pull this item from the consent agenda. During the course of the public hearings, I hand the clerk a list of appeals where I know someone is present, or where there is additional material which should be noted for the record.

However, it's not required that someone "check-in" to speak. At the end of my appeals, the Council President will ask if anyone is present to speak to any of the other legislative hearing items. A person could also raise a hand and speak at that time. If no one wishes to speak, my recommendation will be adopted as a part of a motion on the balance of the consent agenda.

The only item for 605 N. Dale St. which is in front of the Council on Wednesday is the condemnation and order to vacate the property. Here is a link to the

If folks are not protesting this recommendation, there is no reason to come. If there is a wish to re-occupy the building or attach conditions, then the Council will need to consider the matter separately, and someone will need to be present.

The appeals of the summary and vehicle abatement orders will be on for public hearing June 3. I am recommending an additional extension, to June 19, for compliance.

I expect the Nuisance Abatement Order for the building will be coming out within the week.
