Dear Council Members,

Our family has lived on Lincoln Avenue, just a couple houses west of Cleveland for 40 years. We are very concerned with the proposed parking mitigation strategy #2 for area 22 residential parking, outlined in the letter from the City of St. Paul dated June 1, 2015.

This mitigation would expand Area 22 permit parking to include ten houses on Cleveland, where onstreet parking would be eliminated. This would unduly impact the availability of parking for the residents on Lincoln and Goodrich, between Cleveland and Finn.

Residents of Cleveland already use off-street parking with garages and parking pads. Several of the houses on these two blocks are student rentals and the concern is that even if those houses have adequate off-street parking, they will purchase the maximum allowed number of parking permits, to share or sell to friends or other students. This will result in the residents once again being unable to park anywhere close to their homes, which was the reason permit parking, was adopted many years ago.

Another problem is when the streets are posted for "No Parking" for street repairs, street sweeping, tree trimming, snow emergencies, etc. Owners of the cars that live on Cleveland, could easily miss seeing the signs and none of the residents will know who the cars belong to in order to alert them. We have already witnessed this happening for years with students that were illegally parked on the street where we live.

Additionally, with the loss of on-street parking on Cleveland, Lincoln will be used for parking for businesses such as Davanni's during evening and weekend hours. We already are subject to late night noise issues, which will only be exasperated by the elimination of parking on Cleveland Avenue and adding more permits.

We are avid bicyclists who ride over two-thousand miles every summer. We have thought from the beginning that Cleveland Avenue is a bad fit for a bike lane. A street like Summit Avenue works well as there are wide driving lanes, much of the street is divided by a median, there are no businesses or apartment complexes along the street, no city buses, etc. Narrowing the driving lanes along Cleveland and eliminating parking is a bad idea. If the proposal is adopted, we ask that you <u>not</u> approve parking mitigation strategy #2.
