## **NOTICE OF PUBLIC HEARING**

## Sound Level Variance – Hmong Freedom Celebration 2015

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

## **Description of Variance**

## Location: Como Park, Como Pool Area by 1151 Como Avenue

**Noise Source:** Lao Family Community of Minnesota, Inc., represented by Tzianeng Vang, J4 2015 Event CEO, has requested a sound level variance in order to present amplified music and announcements during the Hmong Freedom Celebration 2015 at Como Park, Como Pool Area by 1151 Como Avenue, from 9:00 a.m. until 8:00 p.m. on Saturday, July 4, 2015 and Sunday, July 5, 2015. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance will only be for the hours of 9:00 a.m. until 8:00 p.m. on July 4 & 5, 2015. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 85 dBA as measured at 50 feet from any stage. 3) All electronically powered equipment, PA systems, loudspeakers and on or near the sporting event fields, must not exceed 75 dBA as measured at the nearest residential receiver. 4) The applicant will provide personnel and equipment, who will conduct sound level monitoring during the event to ensure compliance with the variance conditions. 5) All electronically powered equipment, PA systems, loudspeakers or similar devices or similar devices must be turned off no later than 8:00 p.m. on each event date.

A public hearing before the City Council on this variance request will be held on:
