## **NOTICE OF PUBLIC HEARING**

## Sound Level Variance for an Outdoor Music Event 2015 Union Depot North Plaza

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. <u>Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.</u>

## **Description of Variance:**

**Location:** Event will be located outdoors at the Union Depot North Plaza, 214 4<sup>th</sup> Street East **Noise Source:** Amber ACE Cleveland/ACEntertainment has applied for a sound level variance in order to provide music outdoors at the Union Depot North Plaza on Saturday July 11, 2015, from 2:00 p.m. to 10:00 p.m., with a pre-event sound check between 12:00 p.m. and 2:00 p.m. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance will be for the hours of 2:00 p.m. to 10:00 p.m., with a pre-event sound check between 12:00 p.m. and 2:00 p.m. on July 11, 2015. 2) All electronically powered equipment used in conjunction with the event must not exceed 90 dBA as measured 50 feet from sound source. 3) The applicant will provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices must be turned off no later than 10:00 p.m. on the date of the event.
