Ben,

Per our phone conversation this morning, I have consulted with the legislative hearing officer and she stated that it would be in your best interest to attend the public hearing tomorrow evening at 5:30 p.m. in Rm 300 Council Chambers. You may arrive 15 minutes before the public hearing and Ms. Moermond can speak to you at that time.

Below is an outline of our basic conditions if the owner's intent is to rehabilitate the building:

- 1) Obtain a code compliance inspection at the Department of Safety and Inspections, 375 Jackson Street, Ste. 220, Saint Paul MN 55101
- 2) Provide a work plan or sworn construction statement, with timelines, for the completion of the rehab of the building;
- 3) A \$5,000 performance deposit must be posted;
- 4) General and subcontractors bids;
- 5) Document demonstrating financial capacity to complete the project (City's estimate cost to rehab exceeds \$60,000);
- 6) Property taxes and vacant building fees must be current;
- 7) Property maintenance owners must continue to maintain the exterior areas of the property such as picking up trash, mowing the lawn, etc.

Mai,

I left you a voicemail as well. I discussed this property with the state again today, and our intention is to prevent the property from being demolished. I have requested payment for the code compliance inspection and will have one ordered ASAP.

Also, I was reviewing the vacant building performance bond information and I believe that US Bank is unable to sign this as it states the person receiving the permit needs to sign. We can make the deposit, but I will not be able to have a contractor execute this before July 1st hearing due to processing delays.

I have attached pictures of one of our most recent work orders completed that shows the condition of the property. We have \$30,000 pending bids to complete repairs but will not proceed if the city is going to demolish the house. However, in order for us to address additional issues, I would need a detailed list of the current violations in order for us to get bids for repair (pending code compliance inspection).

On our call last week, you mentioned that Marcia was the person who would be making the recommendation to the city for demolition, but based on the pictures I have provided and my stated intent that we want to prevent the demolition of the house, will the city grant an extension of time to address the issues? The redemption period for this foreclosure just expired on May 7th, 2015, and we have been completing work as we have been able, but do not want to continue to repair a house the city will demolish.

If Marcia would be willing to call me to discuss prior to the council hearing, I would greatly appreciate it! I am willing to attend the city council meeting to explain our intent, but I am unsure if that is the best avenue to pursue at this point due to the bond issue.
