The Department of Safety and Inspections (DSI) recommends the following conditions: 1) Variance will be for the hours of 6:00 p.m. until 10:00 p.m. on Thursday, August 6, 2015, from 2:00 p.m. to 11:00 p.m. on Friday, August 7, 2015, from 9:00 a.m. to 11:00 p.m. on Saturday, August 8, 2015 and from 9:00 a.m. to 8:00 p.m. on Sunday, August 9, 2015. 2) Target Main Stage: All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 100 dBA at the sound mix or 100 feet from stage. whichever is the shorter distance. 3) Pub Stage (Tent): All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 95 dBA at the sound mix or 50 feet from stage, whichever is the shorter distance. 4) All Other Stages: All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 95 dBA at the sound mix or 50 feet from stage, whichever is the shorter distance. 5) The applicant shall provide personnel and equipment who will provide continuous sound level monitoring at each sound mix during the hours of the variance. 6) All electronically powered equipment, PA systems, loudspeakers, or similar devices located on the event grounds must be turned off no later than the above identified times at the specific locations on the event dates.
