NOTICE OF PUBLIC HEARING

Melissa Berg Party – Sound Level Variance August 21, 2015

TO: District 10 Como Community Council

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. <u>Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.</u>

Description of Variance:

Location: 1643 Huron Street

Noise Source: Melissa Berg has requested a sound level variance in order to present a live band with speakers from 7:00 p.m. until 10:00 p.m., with a pre-event sound check from 6:00 p.m. until 7:00 p.m. on August 21, 2015 at 1643 Huron Street. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) Variance will be for a live band with speakers for the hours from 7:00 p.m. to 10:00 p.m., with a pre-event sound check from 6:00 p.m. to 10:00 p.m., with a pre-event sound check from 6:00 p.m. until 7:00 p.m. on Friday, August 21, 2015. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 85 dBA at 50 feet from the noise source from 6:00 p.m. until 10:00 p.m. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices 12, 2015.
