This is in regards to a notice received on June 3<sup>rd</sup>, 2015 that the driveway on my property currently no longer leads to legal off street parking and that it needs to be removed by myself by August 17. I'm appealing this based on the fact that while I'm aware my driveway does is nonconforming; the driveway and curb cut have existed the entire time that I've lived in the home beginning 2012. There have been no modifications or new construction or landscaping that has altered the look of my home and said driveway. Based on the age of the cement and the fact that the red maple that is abutting the driveway clearly has overgrown the driveway one can assume at this point that the driveway has been in its place for approximately the last 20 years at a minimum. A brief and cursory view of homes in my neighborhood and other areas of St. Paul have clearly shown that this is not a rare occurrence. There are multiple homes that have similar circumstances in regards to their appearance. The driveway and curb cut is consistent with the look of the neighborhood as has been properly maintained up until this time.

This driveway continues to be of use to the family as it does allow access to the rear of the home particularly the hot tub that is placed in the rear of the home as well and allows for services to maintain said hot tub. Attached is a list of homes that based on our brief to our visit around the neighborhood are clearly also out of code and require a similar correction notice highlighting the fact that this clearly is a common occurrence in the city of St. Paul and should for no reason be necessarily removed at this time

### **CORRECTION NOTICE**

Dear Sir or Madam:

The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on May 28, 2015 and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code<sup>1</sup> (see footnote 1, below).

1. The driveway no longer leads to legal off-street parking. Per 63.310 of legislative Code, "driveway and curb cut shall be removed and landscaping and curbing be restored." Please note that curb restoration must be done by a contractor approved by the City to do such work.

You may be interested in appealing these Orders. Instructions are below, and are highlighted. Deadlines exist for the appeal process.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will reinspect these premises on or after August 17, 2015, by which date the violations noted must be corrected. Failure to correct these deficiencies may result in the issuance of criminal charges<sup>2</sup> and/or a civil lawsuit, and possible abatement/assessment by the City. All repairs and new installations must be made in accordance with the appropriate codes. Permits may be obtained by calling 651-266-8989.

You may file an appeal to this notice by contacting the City Clerk at 651-266-8585. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal, and pay a filing fee.)

If you have any questions or request additional information, please contact me. To arrange an appointment or request an extension of time to complete repairs, you will need to speak directly to me at 651-266-1914.
