

I firmly disagree with the order stating that the "....stakes and obstructions along the driveway property line is causing an exit obstruction, interferes or renders dangerous for passage and a hazard for emergency response vehicles."

I am not clear as to what the "obstructions" referenced are? There are poles/stakes alongside my driveway, against the edge of my driveway.

As you can see from the pictures attached, vehicles are free to enter and exit the driveway. These poles on my driveline in no way interfere with anyone entering and exiting. The real issue is the neighbor cannot back up in a straight line and continues to drive over onto my driveway, thereby causing the edge of the asphalt to break and crumble. I have on several occasions asked her not to drive over the edge of my driveway. (I do have copies of all the communication with this neighbor, if needed.)

If you do not correct the nuisance or file an appeal before June 29, 2015, the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes. Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipment, etc. The rate will be approximately \$260.00 per hour plus expenses for abatement.

You must maintain the premises in a clean condition and provide proper and adequate refuse storage at all times
