



Dear Legislative Hearing Officer,

Ms. Kris Skow-Fiske, Fire Inspector, issued a notice to comply regarding the need for a ducted hood and hood fire suppression system to be installed above the stove top in the Sitzmann Hall kitchen. 2055 Summit Avenue, hereafter referred to as Sitzmann Hall, houses the University of St. Thomas' Center for Catholic Studies (Figures 1 &2). Based upon my discussions with Ms. Skow-Fiske, it is my understanding that she believes this kitchen is a commercial kitchen, and therefore must comply with fire code requirements for a ducted ventilation system and duct fire suppression. St. Thomas strongly disagrees with the need for such a hood and fire suppression system and is therefore appealing this notice. St. Thomas contends the kitchen is not a commercial kitchen and further that the City of St. Paul reviewed and approved the construction plans for the kitchen, and inspected and approved the construction of the kitchen as it now exists.

The Sitzmann Hall kitchen (Figures 3, 4 and 5) was constructed during a major renovation of the building in 2002. At the time kitchen was planned, it was never St. Thomas' intent to operate that kitchen as a commercial kitchen. The kitchen was provided primarily as an amenity for UST faculty and staff (Figure 6) working within the building, with the secondary purpose of providing occasional support for receptions and seminars hosted in Sitzmann Hall. Meals for these events are not prepared in Sitzmann Hall; the kitchen is used for storage, staging and sometimes rewarming of meal items.

The 2002 renovation plans were prepared by Anderson Dale Architects under the direct supervision of Mr. Paul Olson, registered architect. The plans were filed with the City of St. Paul. On April 3, 2002, prior to obtaining the permit for the construction work, Mr. Olson (Anderson Dale), Mr. Doug Hennes (UST – University Relations) and Mr. Paul Biason (McCough Construction) met with Mr. Jim Bloom, with City of St. Paul Building Permitting and Plan Review. During that meeting the nature of the kitchen was discussed with Mr. Bloom, and he concurred with our opinion that the kitchen was not a commercial kitchen.

UST filed the construction plans with the City, and obtained a building permit based upon those plans and our discussions with the City. The City inspected the construction – including

the kitchen - at the conclusion of the 2002 renovations and issued a certificate of occupancy for the building. At that time the City took no exception to the construction of the kitchen.

Sitzmann Hall was inspected by Ms. Skow-Fiske, on July 12, 2010. The kitchen had not been altered since 2002. Ms. Skow-Fiske had full opportunity to inspect the kitchen at that time and found no deficiencies associated with the kitchen. I am aware of at least one other fire inspection between 2002 and 2010, and no deficiency was found in the kitchen during that inspection. There have been no alterations in equipment, design or use of the Sitzmann kitchen between the July 12, 2010 inspection and the current inspection. I am therefore at a loss to explain why a kitchen that passed multiple inspections by St. Paul Fire Inspection, would suddenly not be incompliance with the fire codes.

The University of St. Thomas built the Sitzmann Hall kitchen in good faith, assuming that we had the full concurrence and approval of the City of St. Paul for the renovations to the building. We submitted plans to the City, discussed those plans with the appropriate building official, and were issued a building permit by the City. At the conclusion of the renovations, the City inspected the building and issued a Certificate of Occupancy.

The corrective actions in the Notice to Comply, are costly and disruptive. If a ducted exhaust hood and a fire suppression system were required, the City had ample opportunity to require them prior to construction, or prior to issuing the Certificate of Occupancy. To require such items, 13 years after the fact seems at best an arbitrary action on the part of the City.

We respectfully request that the two citations regarding installation of a ducted hood and fire suppression system be vacated.





- 2. KITCHEN 2055 MSFC 609.2 Provide an approved hood and duct ventilation system to remove the grease laden vapors. This work may require a permit(s). Call DSI at (651) 266-9090.


