It has been almost 4 years since this DSI nightmare began. In that time you have locked me up, killed my pets, lied to me, pulled back my regular inspector, raped my house 2 days before Christmas, even taking the presents, then left the house unsecured for the scavengers to finish the destruction. With the demolition on April 5, the beautiful restoration gave up. On Oct 1 the Minnesota appellate court will hear my plea -- the first real judges to rule on this case.
