I then went back to the Property Ownership Spreadsheet and sorted out the lot number, owner, the poperty owned by owner and the owners mailing address to make the whole process easier. This sheet is attached. I then modified the first letter we made and included lines where the owner could print his or her name, address, a daytime phone number and signature.
