

Yes I am the owner of the duplex. I bought the duplex in 2009 for my wife and I to retire in. Please check on the frequency of calls to the property in the last five months versus the previous five years.

Thank you very very much for responding. I have been having trouble with the tenant and it has only been getting worse. I did call the Central District phone line on Monday to ask how to file a report. At that time I was told to simply call an officer to my home to file a report. I didn't want to tip my hand to the tenant so I elected to email Janie who then told me to contact you.

I am very sorry to bother you but I am at the end of the line. My wife and I live in the upper unit of a duplex. We rent the lower unit and have had pretty good luck until now. My wife returned from Mexico only three months ago after waiting four years for a visa after being improperly deported (that's another story).

The tenant's are making our life in our home miserable. The stink of skunk weed wakes us up shortly after Julian returns from work at 1-2 am. My eyes water from the junk and the smoke alarms have actually gone off. When we open our bedroom door you could think a skunk had unnated beneath the furniture.

The arguing with Michelle is very frequent night or day. I think the State had placed an OFP against Julian earlier this year but Michelle asked that it be removed a month or so ago. Last night there was another physical altercation between Julian and Michelle and I called 911. Officer Daniel Peck and his partner responded to the call but could not do much and now Julian will hide his stash at another location.

I have tried to contact an attorney but all seem to be busy and the response is slow. I have tried to get information from the Housing Court but it does not sound hopeful. I will call to talk shortly to talk via phone. If

I don't want to bother you too much, but I want to inform you of the latest on my bad tenant problem and keep in touch as much as practical. I am getting conflicting information from every government agency I call and I am still trying to find an attorney.

I think bad tenant (Julian Ramirez) is trying to lay low and live elsewhere until he can come out from under the rocks. Maybe it's a game ... I can't kick him out if he isn't living here. He's been taking a few boxes out bit by bit, day and night. He returned last night at approximately 4:40 am (?) and woke us up at 4:50 because he and Michelle (Bejarano) were arguing as usual.

He probably wanted to secure his stash and pack some more boxes. It sounded like he locked Michelle out of "his" room and left "his" commercial floor fan running in "his" bedroom to air out the stench. It appears he has spent the whole week cleaning his room, bedding, clothing, and moving his stash. I'm sorry the officers who came over on Monday morning missed a golden opportunity to catch the bad guy. I realize you are very limited in what you can do, but isn't a history of abusive behavior, a history of previous traffic-insurance-

drug violations, changing locks on another person's property, and the witness of the owner who lives upstairs and smells skunk weed 3-4 times per week enough for probable cause?

I'm still trying to talk to an attorney, but his threats to make my life miserable and his bragging of choke holds that leave no mark are very problematic. He is a player who has played the law all of his life. He can sit around all day with other scofflaws coming up with ridiculous strategies while people who have to work for a living don't have that luxury. I expect an attorney will give us all sorts of options that may or may not work and use up most of our bank account in the process.

Please keep in touch or pass these emails along to anyone who could help us out. Could I speak with the city attorney or judge who rescinded the earlier Order for Protection? Shouldn't there be some sort of condition or probation attached to that? I am sorry to bother you. I know you have dozens of other cases like mine and thousands of other bad guys to worry about. Thank you for your time and please let us know of anyone who could help.

Sorry for the delay ... I don't have internet access unless I am at work or go to a coffee shop.


The lease is totally informal. They stalled for months and never gave me references or even their names until well after they were moved in. My mistake, I will never do that again.

In short, the lease is month to month and I would assume that stinking up the house with skunk weed and making our home unlivable for my wife and I would be enough to get rid of them. The threats were the last straw.

I am getting wildly different opinions from your officers (obtain a 30 day notice from Housing Court); Housing Court (give them an informal 30 Days to Vacate and then buy an Eviction Order if they are not gone); and acquaintances. I am also trying to retain an attorney but they seem to be too busy for quick action.

Thanks for your concern and responding. I think the drugs are long gone to a new location. Now I have to worry about retaliation, an obtuse legal system, threats, theft, and destruction of property. He already keyed my car, but who's going to believe me?

The way it works is this. You cant just kick anyone out. If you are on a month to month refuse to renew their lease and tell them they have 30 days to get out. If they still refuse to leave you will have to set a court date for an unlawful detainer. In the meantime continue to document each and every incident you have with them. Get witnesses to verify what you are experiencing.

Unfortunately when you don't perform back grounds and get references and have a solid leases these are the things that can happen. The people out there that will take advantage of you know the laws and how to best exploit you the owner, renter beware.

There are a few ways of getting it verified he received it. One way is certified mail, another is serving him in person, it doesn't need to be a formal (lawyer written) form. Send him/her an email you should be able to verify it was opened and read.

The way you can help yourself is call the police on him. It's a record of calls for service to the address. Is he on the lease? If not does it violate her lease? Are they paying their rent on time? Just a few of the issues that can help you.

If he is not on the lease and has assault you attempt to get a harassment order or order for protection against him. I'm not saying you will be granted an order but it's another avenue you can try. I also suggest calling the police when he is threatening you, smoking drugs, or anything else that is causing you issues.

Let us know if there is anything else we can help with.

Thanks again. The issues surrounding my bad tenant have settled a bit since last week. There have been no more police calls, no noticable drug use to stink up the house, less arguments at all hours of the day and night, less door slamming at all hours of the day and night, etc, etc.

He has taken the time to short me on the rent and state that I have been harassing him. Like making our house unlivable with skunk weed, keeping us awake, damaging property, and threatening to "make my life miserable" is not harassment?

You mentioned earlier that you worked with problem properties. Is there a way I can obtain a record of all police calls to my address? We moved into this house in late 2009 and I would like to see the calls to this address before that time, since that time, and especially in the time that Julian and Michelle have lived here (since May of this year).

Also, is there a way I can get a background check on Mr. Ramirez. I saw something online a few months ago which led me to believe he has had several driving violations and possibly possession violations.

Finally, what about the OFP? Would there be a record of that and the circumstances of it's removal.

I think I will need these documents because I am sure he and she will deny ever using drugs or damaging property. I know the law is very convoluted, but hopefully a wise court could put 2+2 together and figure this out (wishful thinking).

I thought I sent you the calls for service for that address, if not let me know and I will resend them. As far as criminal background you need to contact the BCA and they have a website you can look it up. OFP are kept with the county and they should be able to get you the available public information on it.

In the future the city of St. Paul offers a class called crime free multi-housing. It helps landlords with information and resources when renting out property (It's mandatory if you have rental property and are renting, but not for someone with a duplex and living in one half of the duplex. So it's not mandatory for you but it offers great insight into the rental world and could help with future renters. If you are interested in that class it's an 8 hour one day class and I believe the cost is under \$50.00. It gives you a lot of helpful information, you should think about it. I have received the Address/Intersecton Report for 579 Bidwell St. Thanks very much for searching back and sending the report to me. Just to be clear:

There were 25 calls in 22 months before the previous owner abandoned the mortgage when the housing market crashed in 2009.

There were 3 calls in 54 months between the time I moved in (with good tenants) and the time Julian Ramirez moved in. Two of these calls were related to one incident (the "theft from auto" call), and I was not even aware of the third call for "missing persons".

There were 5 calls in 6 months since Julian Ramirez has lived here and I would like to know why the police did not send out social services to investigate the call I made regarding domestic abuse when he had already had one OFP earlier in the year?

It may be my word and my wife's word against his word and his abused girlfriend's word, but someone is dropping the ball on this. Common sense, history, and his scofflaw record should be enough to alert the County

Attorney or County Judge who handled the OFP.

We know what we heard day and night. We know what we smelled day and night. We guess that no one will do anything until he starts throwing the 13 year old girl around the apartment, hopefully a different apartment. Pretty good for someone who told me that Brian Fitch "got him good" when referring to Officer Scott Patrick last summer.

I am sorry I am venting again. My wife and I are at the end of our rope. I know your hands are tied, but I also know that some person or some agency should be looking at this. Forgive me and please let me know if you think of something that might help.
