## NOTICE OF CONDEMNATION UNFIT FOR HUMAN HABITATION ORDER TO VACATE

Dear Property Representative:

Your building was inspected on August 27, 2015.

The building was found to be unsafe, unfit for human habitation, a public nuisance, a hazard to the public welfare or otherwise dangerous to human life. A Condemnation Placard has been posted on the building.

## CONDEMNATION OF THE BUILDING REVOKES THE CERTIFICATE OF OCCUPANCY.

Failure to complete the corrections may result in a criminal citation. The Saint Paul Legislative Code requires that no building be occupied without a Fire Certificate of Occupancy.

## **DEFICIENCY LIST**

- 1. SPLC 34.14 (2), 34.34 (5) Provide an approved electrical and / gas service adequate to meet the buildings needs. This work may require a permit(s), call DSI at (651) 266-9090.-
- 2. MSFC 304.1 Remove excessive combustible storage and/or vegetation from exterior property areas.-

- 3. SPLC 45.03 (6) Cut and maintain the grass/weeds less than 8 inches tall.-
- 4. SPLC 34.09 (3), 34.32 (3) Repair and maintain the window glass.-
- 5. SPLC 34.09 (3), 34.33 (3) -Provide or repair and maintain the window screen.-
- 6. SPLC 34.11 (6), 34.34 (3) Provide service of heating facility by a licensed contractor which must include a carbon monoxide test. Submit a completed copy of the Saint Paul Fire Marshal's Existing Fuel Burning Equipment Safety Test Report to this office.
- 7. SPLC 39.02(c) Complete and sign the smoke detector affidavit and return it to this office.

You have the right to appeal these orders to the Legislative Hearing Officer.
