**CORRECTION NOTICE - COMPLAINT INSPECTION**

An inspection was made of your building on April 1, 2015 in response to a referral. You are hereby notified that the following deficiency list must be corrected immediately.

**A reinspection will be made on October 7, 2015 at 10:00am.**

Failure to comply may result in a criminal citation. The code also provides for the assessment of additional reinspection fees.

**DEFICIENCY LIST**

1. SPLC 34.19 - Provide the inspector access to the building. -Allow access to verify all of the corrections have been made.
2. EXTERIOR - GARAGE - SPLC 34.08(5), 34.32(3) - All accessory structures including, but not limited to, detached garages, sheds and fences shall be maintained structurally sound and in good repair. Provide and maintain exterior unprotected surfaces painted or protected from the elements. -Scrape and paint where needed.
3. EXTERIOR - ROOF - SPLC 34.09 (1) e, 34.32 (1) d - Provide and maintained the roof weather tight and free from defects. -Shingles are deteriorated.
4. EXTERIOR - SPLC 34.09 (1) b,c, 34.33 (1) b, c - Provide and maintain all exterior walls free from holes and deterioration. All wood exterior unprotected surfaces must be painted or protected from the elements and maintained in a professional manner free from chipped or peeling paint. -Scrape and paint where needed. -Areas of siding and window sill with missing/peeling paint.
5. EXTERIOR - SPLC 34.09 (3), 34.33 (3) -Provide or repair and maintain the window screens, where damaged, broken, or missing.

6. INTERIOR - MAIN HALLWAY - MSFC 605.1 - Remove unapproved exposed wiring and install in accordance with the electrical code. This work may require a permit(s). Call DSI at (651) 266-9090. -Exposed electrical in the closet.
7. INTERIOR - MAIN HALLWAY - NEC 110-26 - Provide and maintain a minimum of 36 inches clearance in front of all electrical panels.-Remove the storage blocking the electrical panel.
8. INTERIOR - MAIN HALLWAY - SPLC 34.10 (7), 34.34 (6) - Repair and maintain the walls in an approved manner. -Cracked, damaged, and missing plaster.
9. UPPER UNIT - SPLC 34.09 (3), 34.32 (3) - Repair and maintain the window in good condition.- Some windows are difficult to open and will pull away from there frames. Some windows will not stay in the openable position.
10. UPPER UNIT - SPLC 34.14 (3), MPC 4715.200.T - Provide and maintain a window or approved ventilation system in all bathrooms. -Bathroom fan was illegally and improperly installed without permits and is not properly vented. This work will require a permit. Contact DSI at 651-266-8989.
11. UPPER UNIT - SPLC 34.11, MSBC 2902.1, SPLC 34.17, MSPC 415.0220 - Repair or replace and maintain all parts of the plumbing system to an operational condition. Repair or replace and maintain an approved private hand sink. This work may require a permit(s). Call DSI at (651) 266-8989. -Hand sink outside the bathroom was installed without permits.
12. UPPER UNIT - MN State Statute 299F.50 Immediately provide and maintain an approved Carbon Monoxide Alarm in a location within ten (10) feet of each sleeping area. Installation shall be in accordance with manufacturer's instructions.-
13. UPPER UNIT DRYER - MSFC 605.5 - Discontinue use of extension cords used in lieu of permanent wiring. -Gas dryer is connected and an extension cord through a doorway was in use.
