## **SPRWS** earns fluoridation award from US CDC

The water utility earned the Water Fluoridation Quality Award from the US Centers for Disease Control and Prevention for 2014.

Fluoridation is the adjustment of fluoride in the drinking water to a level that is effective for preventing tooth decay. Fluoridation has been shown to prevent about 25 percent of tooth decay in children and adults, said Katherine Weno, a dentist and director of the CDC Division of Oral Health. Fluoridation has been hailed by the CDC as one of the 10 great public health achievements in the 20th century.

Melvin J. Dupre, age 95, a WWII Army veteran, a lifetime Centerville resident, and a retiree of Saint Paul Regional Water Services, passed away October 9, 2015.

Melvin joined the water utility in 1947 as a watershed laborer and station fireman. He held those positions until 1954, when he became a pump station engineer. In 1957, he became a watershed foreman. In 1964, he was promoted to watershed foreman II, the position from which he retired in 1985.

Melvin worked for the water utility for just short of 38 years.

He was buried on October 14 at St. Genevieve's Church Cemetery.
