Re: Charter Commission Recommendation to Amend Charter Section 17.07 regarding On-Sale Liquor Licenses issued to restaurants, pursuant to Minnesota Statutes § 410.12, subd. 7

Dear Ms. Moore:

This letter is to advise you that on November 10, 2015, the Charter Commission of the City of Saint Paul voted to recommend that Section 17.07 of the Charter be amended by ordinance adopted unanimously by the Council, pursuant to Minnesota Statutes § 410.12, subd. 7 (2014).

Minnesota Statutes § 410.12, subd. 7 (2014) requires the city to publish notice of a public hearing on this proposal within one month of receiving this recommendation. The notice must contain the text of the proposed amendment. The city council must hold the public hearing at least two weeks, but not more than one month after the notice is published. Within one month of the public hearing, the city council must vote on the proposal. It is adopted if it receives the affirmative vote of all seven of the councilmembers and is approved by the mayor. The ordinance must be published as in the case of other ordinances. It becomes effective 90 after passage, approval and publication.

For your convenience I have also enclosed proposed ordinance to accomplish the amendment.

NOTICE OF PUBLIC HEARING

The Saint Paul City Council will conduct a public hearing on Wednesday, December 2, 2015 at 5:30 p.m. in Council Chambers, 3rd floor City Hall - Court House regarding the Saint Paul Charter Commission recommendation to the City of Saint Paul that the following charter amendment be made by ordinance:

Amending Charter Section 17.07 regarding On-Sale Liquor Licenses issued to restaurants, pursuant to Minnesota Statutes § 410.12, subd. 7.

The Council of the City of Saint Paul does ordain:

Section 1.

Pursuant to Minnesota Statutes § 410.12, subd. 7, on November 10, 2015, the Saint Paul Charter Commission recommended to the City of Saint Paul that certain charter amendments, as more fully stated below, be made by ordinance. Public notice has been given, and a public hearing has been held according to law. The Council of Saint Paul, by unanimous vote, hereby amends Charter Section 17.07 as follows:

Section 2.

Sec. 17.07. - On-sale liquor licenses.

The issuance and location of on-sale intoxicating liquor licenses shall be subject to the provisions of this section; provided, that this shall not apply to or include on-sale wine licenses-, or on-sale liquor licenses issued to restaurants.

Section 3.

This ordinance shall take effect ninety (90) days after passage, approval and publication.
