## **NOTICE OF PUBLIC HEARING**

## Become Co/Red Bull Frozen City Event 2016 Sound Level Variance 3

TO: West Side Community Organization, Summit Hill Association, and CapitolRiver Council District 17

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

## **Description of Variance (SLV #3):**

<u>Locations</u>: Shot 4, Ramsey Street Hill; Shot 5, City Hall; Shot 6, Mickey's Diner; Shot 7, Cathedral Park and Shot 1, Smith Avenue Bridge

Noise Source: Become Co/Red Bull Media House Frozen City Event 2016, represented by Luke Seile, Managing Partner/ Producer, has requested a sound level variance in order to use a specialized snowmobile for Sound Level Variance 3 (SLV#3) at the following locations: Shot 4, Ramsey Street Hill; Shot 5, City Hall; Shot 6, Mickey's Diner; Shot 7, Cathedral Park and Shot 1b, Smith Avenue Bridge. The Department of Safety and Inspections (DSI) recommends the following conditions: 1. The SLV #3 Variance shall be for the hours of 8:00 a.m. to 6:00 p.m., with a pre-event sound check from 7:30 a.m. to 8:30 a.m. on Wednesday, January 6, 2016 until Monday, January 11, 2016; Wednesday, January 13, 2016 until Monday, January 18, 2016 and/or Wednesday, January 20, 2016 until Monday, January 25, 2016 for the following locations: Shot 4, Ramsey Street Hill; Shot 5, City Hall; Shot 6, Mickey's Diner; Shot 7, Cathedral Park and Shot 1b, Smith Avenue Bridge. 2. All noise coming from the specialized snowmobile used in conjunction with the event shall not exceed 91 dBA as measured at 50 feet from the sound source. 3. The applicant shall provide personnel and equipment to monitor sound level limits as specified in Condition #2. 4. All specialized snowmobile sound shall be turned off no later than 6:00 p.m. on Wednesday, January 6, 2016 until Monday, January 11, 2016; Wednesday, January 13, 2016 until Monday, January 18, 2016 and/or Wednesday, January 20, 2016 until Monday, January 25, 2016.
