Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting scheduled for **Wednesday**, **December 16**, **2015** at **5:30** p.m., in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse.

Enclosed are copies of the resolution and supporting documents which will be presented to City Council for their consideration. This is an uncontested matter concerning the fact that: 1) you allowed a patron into the establishment on September 20, 2015, without proper identification in violation of license condition #5 and 2) you were unable to provide video surveillance to the Saint Paul Police Department when requested on three separate occasions (October 7<sup>th</sup>, 11<sup>th</sup> and 21<sup>st</sup> 2015) in violation of license condition #2. Therefore, the licensee office will recommend a \$1,000.00 matrix penalty.
