Squad #373 (MDunaski/JRaichert) went to 883 Payne, Louie's Bar on a fight call. Call time 0010 hours on 9-20-2015.

It should be noted that I provided bar staff with a phone number to contact me on due to several recent disturbances, gambling issues, narcotics complaints, and fights. I was contacted at approximately 0005 hours on 9-20-2015 about an unruly group that was refusing to leave the front of the bar and threatening staff.

When we arrived on scene we cleared the outside parking lot area and then went into the bar to do a premise check. While inside the bar I observed a possible wanted party sitting at a booth.

Myself and assisting officers went back into the bar and asked ABDULLAH his name. He told us he was ANTHONY CARTER, DOB 8-30-1981. ABDULLAH further indicated that he had a Texas ID but not on his person. It should be noted that all patrons of Louie's bar are suppose to have ID to verify their age at the bar. Another patron indicated that they new ABDULLAH as "Naj".

We arrested ABDULLAH without incident and verified his tattoos as an additional identifier.

ABDULLAH was booked on his warrant and cited for false name (#620900273509).

Squad #910 (Watch Cmdr Lozoya) approved the arrest.

#### PUBLIC NARRATIVE

Arrest made without incident. ABDULLAH provided a false name to police and had no ID on his person. ABDULLAH was served a drink at the bar. Rules set up for the bar require patron's to have ID on their person.
