We heard Abernatha yell something to the female and continue to walk closer to her. We thought this was very suspicious due to

the age of the female, the area is a high crime rate area and she was in alone late at night. We turned around to investigate further.

We approached Abernatha as he was walking down the middle of the street. I had my window rolled down and asked Abernatha to take his hands out of his vest pockets for Officer safety purposes. I asked Abernatha if he knew the female he was talking to and he stated "No". I told Abernatha again to take his hands out of his vest pockets. At this time Abernatha looked side to side as though he was going to run and then with his left hand took something out of his left pocket of his vest and put it in his mouth. At this time I exited the drivers seat to try and stop him from putting the suspicious object in his mouth.

I grabbed a hold of his right hand that was still in his vest pocket but he would not take his hands out. I then tried to gain control of his left hand which he put back inside of his vest pocket after putting something in his mouth. I ordered Abernatha to open his mouth but he would not obey. I then ordered Abernatha to give me his hands and he again would not obey. I told Abernatha to stop resisting and at this time he tried to turn to walk away and went down the ground.

Abernatha was on the ground face down with both hands underneath him refusing to give us his hands very tensed up. I continued to give verbal directives asking for his hands and he continued to not comply. I was then able to grab a hold of his right hand and get a handcuff on it. Still struggling with Abernatha's left hand Officer Carle exited the vehicle and came to assist from the passenger side. Officer Carle gained control of one arm and I had the other. At this time I was able to place the other handcuff on him.

With Abernatha still on the ground we searched him for any other weapons and then got him to his feet. Abernatha stated he put a small baggy of marijuana in his mouth because he was scared of what would happen to him if he got caught with it. Abernatha also had a small baggy of marijuana in his left shoe.

Officer Bravo and Maloney (squad 360) spoke to the juvenile female. See supplement report.

Officer Hamblin and Fields squad 384 (1386) transported Abernatha to the Ramsey County LEC. Abernatha was cited for obstruction of legal process and poss of small amount of marijuana.
