#### NARRATIVE

No ICC Video available.

On 10/11/2015 at 0057 hours, Squad #326 (M. Norman/ A. Bohlen) was dispatched to 883 Payne Ave (Louie's Bar) for an assault. We were informed a black female suspect had hit a victim in the head with a beer bottle.

When we arrived, I met the victim who was identified as, DOLLY ANN KESSEL (DOB: 06/30/1976; 275 CIMARRON, LAKE ELMO 55042; C/P: 612-817-1710). I observed a small bump on KESSEL'S forehead.

KESSEL told me the following: She works as a bartender for Louie's Bar. She announced to bar patrons the bar would be closing in five minutes and they needed to finish their drinks. Once the bar was closed she grabbed a partially filled drink off the bar and poured it out. The drink belonged to a black female standing at the bar. The black female was with a friend. The black female then began to argue with KESSEL over her taking her drink. She was then stuck in the forehead by the black females friend. The suspect hit her in the forehead with an empty Miller Lite beer bottle. The bottle did not break.

KESSEL then told me the security guard escorted the female suspect from the bar. She described the female suspect as a black female, short hair, 5'04" tall, 250 to 275 lbs, wearing a white shirt, jean jacket and blue jeans, white shoes and a pink hat. KESSEL has never seen the female suspect in the bar before. The female suspect had fled the area before officers arrived.

I asked KESSEL if they had video surveillance of the bar available. She told me the manager has access to the video and was not currently on scene. She told me the manage would recover the video surveillance in the morning when she came to work. She would call Police when the video footage was available.

I took the following photos of the scene and of KESSEL'S injury: Included with this report is a signed medical release.

### PUBLIC NARRATIVE

On 10/11/2015 at 0057 hours, Squad #326 was dispatched to 883 Payne Ave (Louie's Bar) for an assault. A female suspect hit a bartender in the head with a glass beer bottle after being told to leave while the bar was closing. The female suspect was escorted out of the bar by security. The female suspect fled the scene before Police arrived. The victim suffered a minor injury to her forehead. The staff at Louie's Bar did not have surveillance video available to officers. The suspect was described as a heavy set black female wearing a white shirt, jean jacket, blue jeans and a pink hat.
