This notice is being served upon you by certified mail as required by Minnesota law.

You may also be served this notice in person. This property will automatically be forfeited to the State of Minnesota unless you demand a judicial review of the seizure within 60 days of the date of this notice.

## How to demand a judicial review.

- 1. File a civil complaint with the court administrator in the county where the selzure occurred.
- 2. Include proof that you served a copy of the complaint on the Department of Revenue.
- 3. List your name as "plaintiff" and the seized property as "defendant" in the title of the complaint.
- 4. State the grounds on which you allege the property was improperly seized and what your ownership interest is in the property. You do not have to pay the court filing fee if it is determined you cannot afford the fee. If the value of the seized property is \$10,000 or less, you can file an action in conciliation court to recover the property, if the value of the seized property is less than \$500, you do not have to pay the conciliation court filing fee.
