## REVISED NOTICE OF PUBLIC HEARING

Visit Saint Paul – Crashed Ice Village Sound Level Variance

TO: West Seventh/Fort Road Federation

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise sources, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

## **Description of Variance:**

<u>Location</u>: The Crashed Ice Village Event will take place on a closed portion of 7<sup>th</sup> Street West between Kellogg Boulevard West (174 7<sup>th</sup> Street West) and Walnut Street North (258 7<sup>th</sup> Street West) on February 27, 2016.

<u>Noise Sources:</u> Visit Saint Paul has applied for a sound level variance in order to broadcast amplified outdoor music using electronically powered equipment at the recommended locations, times and decibel level (dBA) limits described below:

- Open-air locations on 7<sup>th</sup> Street West between 2:00 p.m. and 10:30 p.m. not to exceed 95 dBA as measured at 50 feet from the sound source. No open-air broadcast allowed after 10:30 p.m.
- Fully enclosed tents adjacent to the above-described location between 2:00 p.m. and 10:30 p.m. not to exceed 95 dBA as measure at 80 feet from the sound source
- Fully enclosed tents adjacent to the above-described location between 10:30 p.m. and 12:00 midnight not
  to exceed 90 dBA as measured at 50 feet from the sound source. No tent originating broadcast allowed
  after 12:00 midnight.
