

## **Description of Variance:**


**Locations**: 995 7<sup>th</sup> Street West

**Noise Source:** Shamrocks Irish Nook has requested a sound level variance to present amplified music within a fully enclosed tent with use of a sound system for a St Patrick's Day Event on Thursday, March 17, 2016 at 995 7<sup>th</sup> Street West. The variance is requested for the hours of 10:00 a.m.to 12:00(Midnight), with a pre-event sound check at 10:00 a.m. on March 17, 2016. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance, within the fully enclosed tent shall be for the hours of 10:00 a.m. to 10:30 p.m., with a pre-event sound check at 10:00 a.m. for the St Patrick's Day Event on Thursday, March 17, 2016. 2) All electronically powered equipment used in conjunction with the event shall not exceed 95 dBA as measured at 50 feet from the sound source. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:30 p.m. on March 17, 2016.
