SPRWS driver was cited for failure to yield the right-of-way to vehicle #2. In November 2013, SPRWS paid \$1798.32 as a property/vehicle damage claim. C-130066	<b>**Settled by city attorney**</b> <b>**Board resolution 15-470**</b> Senait Tefai Ghebray	On 2/1/2013 SPRWS truck No. 576 was on Hwy. 36 EB approaching English St. in right lane. Vehicles ahead were stopped at a red light. SPRWS vehicle rear-ended claimant No. 1's vehicle, forcing it into claimant No. 2's vehicle. This is a personal injury settlement for the passenger in Vehicle No. 1.	\$20,000.00
C-140428	Commerical Utilities Inc/ Tony Curella 1146 East Seventh Street, Saint Paul, MN 55106	On 8/01/2014 a water service stubbed to and capped at the property line of 1870 English St. was found to be leaking. Commercial Utilities was repairing a separate water service in private property nearby. The leak was in the right-of-way and the responsibility of SPRWS to fix. Commerical Utilities dug and repaired the leaky service on behalf of SPRWS, which was approved by SPRWS plumbing inspector.	\$600.00

On 8/6/2014, Commercial Utilities replaced the lead service line. Shortly after, the customer complained the water line was still leaking and causing problems. Commercial Utilities replaced the new line. Customer still complained of water problems. SPRWS determined that the leak orginated from 649 Reaney Ave, not 651 Reaney Ave. Payment is for work associated with the 2nd water service replacement at 651 Reaney Ave.	\$1,500.00

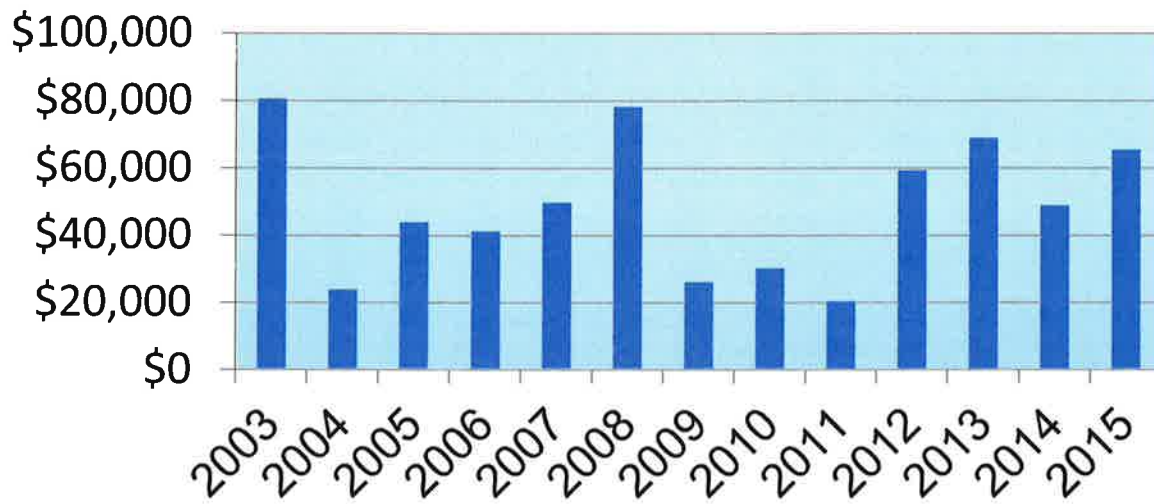

Price 1078 Bonnieview Circle, Saint Paul, MN 55129	On 7/30/2014 a service order was generated to check on a leak at 651 Reaney Ave. SPRWS determined that the leak was in property and ordered the lead service line be replaced by owner. After replacing the line, SPRWS determined that the leak originated from 649 Reaney Ave, not 651 Reaney Ave. The lead service line at 651 Reaney did not need to be replaced. However, customer realized benefit from new copper line. Settlement is for half the cost of the lead line replacement.	\$1,650.00
C-140494	Mai Yang Vue C/O Moua Law Office 261 Ruth Street North, Saint Paul, MN 55119	On 12/01/2014 SPRWS vehicle was travelling EB on Larpenteur Ave. in the left lane, then switched to the right lane to avoid a tow truck blocking the lane just past Jackson St. As SPRWS vehicle crested the hill in right lane, it struck (rear-ended) a car parked legally on the right portion of the right lane. This is settlement for property damage claim.	\$3,498.60

On 2/6/2015 the sewer line owned by claimant needed to be cleaned out. It was determined that SPRWS had damaged the claimant sewer line during backfilling. On 2/12/2015 Grant Utilities excavated and repaired the broken sewer line.	\$6,205.50

Due to the location of the curb stop and the claimant's curb stop at 2310 Pond Ave., SPRWS shut off the wrong service. On 4/16/2015 claimant called plumber to repair the valve in the master toilet. There were no previous issues with that toilet valve not shutting off. SPRWS plumbing inspector confirmed this is possible when the water is shut off.	\$225.00

On 5/8/2015 SPRWS foreman determined that driveway restoration was not a repair that SPRWS could complete due to the custom concrete in the driveway. SPRWS is responsible for restoration in the public right-of-way.	\$1,495.00
