Paul Johnson, been a runner for many years, coached at Highland Park. His family has done many events in Saint Paul. His kids have volunteered there. He would second the need to research the impact on races. A lot of consideration has gone into races. There is not a big profit margins on them. By limiting traffic, there will be races that will not operate anymore. Where will the races go? What is the economic impact? He would also be concerned with the safety of the runners. Traffic will try to get through, police. It takes a lot more thought when it comes to these processes.

Mary Anderson works on 200 events each year. Would reiterate the concern of the two previous. She is happy with the amendment. There are other considerations about traffic crossing. They should take that into consideration.

(Those in support spoke next)

Lynel Nelson has been here once before. This has been talked about quite a bit. She is here to support the Council doing anything they can to limit these races. They are having about 12 a year. How do they get out when both exits are closed? The frequency of races on Shepard is insane. The portable potties, litter, frequency. She is in favor of anything that brings quiet to the Upper landing. Taxes are high. People will wonder if they should buy there.

Kendra Garrett spoke in favor of the ordinances. They should be able to get in and out of the homes. One side is Shepard and the other side is the river. The police do their best. Dan Jellinek stated this is an amendment to the City charter and a companion to the one adopted a few hours ago. This is a culmination of DSI, District Council, business owners, and residents evaluating the changing market. One issue is the ability to obtain on sale liquor licenses. The changing restaurant market is beyond wine and beer.

Tom Goldstein said they are saying they need more liquor sales in Saint Paul. They have unlimited beer and wine. They want to expand with more liquor. They want to make it more competitive. We are saying beer and wine are not enough. Currently, they have 7 licenses in Wards 5, 7, 9. The problems are in wards 2, 3, 4. Instead of addressing that problem, we are saying to have unlimited licenses. Councilmember Finney remembers when as a police officer he dealt with liquor licenses. Now, we are saying the discretion will be removed form DSI (Department of Safety and Inspections). Public Safety is to promote health and safety for all. We are told we don't have enough inspectors to address housing problems. There are no marketing studies. They were no meetings with the public, no hearings. The charter is St. Paul's constitution. Why are we voting on this now in December? If there is a desire to become competitive, let's have a public hearing and do it next year. Maybe the new councilmembers will make there not be enough votes. We continue to make changes and do not seek public input. All councilmembers are not here. Finney was not elected by the voters.

John O'Brien owner of the Commodore Squash Club. The Commodore is not open. He owned it since 1995. We have a situation where John Rupp is in the process of expanding his liquor license into his former fitness center. This would normally echo a public review. Whenever there is a massive impact on parking, it is important that the neighborhood be heard. Now it wll be worse when the banquet facility comes on line. He has weddings booked through the end of summer. Should this be the will of the neighborhood? What about DSI?

Stark asked is this a restaurant. Obrien responded the Commodore is defined that way. He reopened the kitchen. The City Council should be involved with this.

(Those in support spoke next.)

David Burley, Highland Grill, Goveland tap, Suzie, all in Ward 3, stated he gets countless requests for strong liquor. At the Highland Grill, they sell Bloody Marys with suchi. They suck; it would be nice if they sell a real Bloody Mary at the Highland Grill.

Burnell, Distrit Council is interested in selling for a number of years. Highland District Council has met with the department. They support the proposed language. Ward 3 has a small number of licenses. How people eat and drink has changed. Thank you for considering.

Debbie Thompson, 128 Café, is in support of the liquor. It will level the playing field. It is hard enough to run a restaurant. They have customers that ask for liquor.

Suzan Dunlop, Jones in the Park, said adding liquor and hard alcohol will not change the way people drink. People just change how they drink. Ray Allen, one of the members of the public, said he is a resident of Highland Park and is in favor of the amendment. He believes Susan Dunlap who spoke about Jones in the park. It is an intimate place, excellent menu. It would be nice to have a martini. It is something you can do in other cities. It would be nice in Highland.

Public hearing to consider the appeal of property owners, Saint Paul Housing and Redevelopment Authority (HRA), to a decision by the Heritage Preservation Commission denying the demolition of 716 Wilson Avenue in the Dayton's Bluff Heritage Preservation District.

Christine Boulware gave staff report. This was before the HPC (Heritage Preservation Commission) on Aug 2012. HPC approved the rehabilitation. It came back to HPC February 2014 where the HPC reviewed and denied proposal for demolition. September 2014, a fire occurred. It went back to the HPC on October 8. Staff recommnded approval of the demolition with conditions. The HPC denied the application for demolition. There was written testimony from 11 people in opposition.

4 people spoke in opposition to the demolition. If the Council overturns the HPC decision and grant the appeal, it is staff's request that the original condition be included with that decision: remove non original siding and archival photographs taken for HPC and historical society for research.

Councilmember Finney asked how long it was vacant. Boulware responded it became a Category 2 on 10-27-2005. There was a code compliance report in 2006. HRA purchased it in 2007.

Finney said it was vacant at least 9 years. Boulware responded yes. It became vacant very quickly as it was lost to the bank.

Finney asked how extensive was the damage from the fire. Boulware responded the fire occurred 9-25-14. The fire was on the front porch, water and smoke damage to the entire interior. Based on photos from prior HPC review, the condition of the building has deteriorated.

Finney asked has it been offered for rehab. Boulware responded she does not have the record on this one.

Finney said he would like to hear from HRA staff and asked the extent of the damage. A male responded the fire damage was primarily the porch and front rooms of the house. The remainder of the house has a lot of soot and smoke damage throughout the first and second floors. It was significant damage.

Finney asked was it offered to developers, members of the public. Male responded not since the fire. They decided to get more interest from developers. They were in contact with 3 developers, but they did not put a proposal forward.

Councilmember Bostrom said the first 2 developers did not think it was feasible before the fire. Male responded they were in receipt of proposals prior to the fire that requested a public subsidy that he felt was unreasonable.

Bostrom asked would \$25,000 to \$50,000 before the fire be reasonable. Male responded it would be at least that.

Joe Musolf, PED, said he is here representing the appellant. The HPC should have granted permission to demolish the building at 716 Wilson based on the following: 1) the HPC staff report noted the building is classified as noncontributing to the Daytons Bluff area, 2) the HPC staff report acknowledged opinion letters from a structural engineer and a construction management specialist which both outlined poor structure of the building. 3) They explained to the HPC that they worked to find rehabilitation to the building. This led to our conclusion that the building is not economically feasible. 4) HPC staff recommended approval of our demolition permit application.

(The following spoke in opposition)

Tom Dimond, 2119 Skyway Drive, stated there is a lot of misinformation here. The Council should give the neighborhood an opportunity to redevelop the property. This property when acquired by the HRA had met all the requirements. It was move-in ready. It did not provide any subsidy for it. The HRA paid \$150,000 for this property. The behavior of how it was managed is the problem. That house was left without a homeowner for 7 years because the HRA would not market it to a homeowner. The HRA has never marketed this to the neighborhood. It has only worked with one developer whose only goal is to create more rental property to a neighborhood that does not need more rental property. Those subsidies are bogus numbers. It met all the code compliance requirements, it was ready to move in, and they refused to

market it. The requirements say to you have to put a sign out, but the HRA refused to put a sign up. They say their rules are exempt. If it was marketed to the public. they would find a homeowner. They will not advertise. Who would buy a \$150,000 property and refuse to sell it to homeowner? The argument was to lift it up and put it on a new foundation. Their statement that they tried to justify is that the basement could not be rehabilitated. You have statements from inspectors that it was a sound structural building. They had a structure inspector go out, who said the report is the foundation is structurally sound. That was a bogus argument to get a subsidy out of it to convert it into a four bedroom rental property. It has nothing to do with getting a homeowner in there. That property could be put back into the tax rolls. The statements by HRA Jonathan Sage Martin is that the context is based on buildings associated with the Shorensting garage and grocery. There is no demo permit for it nor for the garage. Demo the house and then they will come back and say they should demo the garage. This is a cirgular argument. Neither of those permits exist. The fire was not helpful, but it impacted the closure of the front porch. It gives the opportunity to restore the porch to its original standing. It says in January 2014, that repair is not an option. That is based on a false claim that you cannot restore the structure, which has been proven untrue by a city inspector and engineer. The reports about the code compliance is that there were two proposals, but there are two proposals by the same people. They only worked with one developer that wanted to do rental. The report from the fire inspection is that the damage is \$60,000 and the value of the building is \$90,000; at a minimum you have \$30,000 value in the building. They should consider letting the neighborhood have a chance to find an alternative to this property.

Brad Griffith, residential realtor, said he is not involved with this property, said the group of neighbors he is active with--Dayton's Bluff Heritage Action Group--would like the Council and HRA to be better stewards of the historic district,. Support it, and better define what the city really wants. Until the new council is seated, this particular property should be in moratorium and other properties in the Daytons Bluff Historic district.

Finney moved to close the public hearing. 6 in favor, none opposed Public hearing is closed.

Finney moved to uphold the appeal by the HRA and move forward with demo.

Councilmember Thune said it is a nice house. All the original woodwork inside, staircase, building cupboard and drawers. Finney and Bostrom responded that was before the fire. Thune said he does not have pictures after the fire. He is hearing from people that it is worth saving. Why can't it be marketed as it is?

Stark had a question for staff. He was trying to read the record for the sequence of events because of things said here tonight. There was a code compliance report in 2006. Was it brought up to code? Musolf responded the HRA purchased it in 2007. Boulware added that the code compliance report was May 2006. The certificate of code compliance was 2007. The HRA brought it later than year in 2007.

Thune asked about the fire. Bouldware responded September 2014.

Finney said there were a number of houses recommended for demolition in Dayton's Bluff. Facades were removed off one building. He walked around all the properties. There are about 6. The only one he is comfortable moving forward with is 716 Wilson. He looked at the fire at the house. This was a lovely house. This house has gotten worse in the years it was closed. He brought this forward today to put it on the agenda instead of putting it out in the future for the new Council to consider and act on it. He considers the amount of time it has been unoccupied: since 2007. It was

acquired in 2005. It has been on fire, its water damaged, and closed up since 2014.

Councilmember Brendmoen said she appreciates that he walked around. In 2005 they were in the middle of a housing crisis. We are talking about how to refurbish homes to keep them up. You cannot replace a historic home. Your first hand perspective is helpful. They have to take greater effort to keep houses standing and maintained so we don't end up coming to this point.

Bostrom said they have to think about the amount that has been invested. At this point, it is time to cut the loss. They can start over and build a house that looks like that for half the price.

#### **Truth in Taxation Hearing**

**PH 15-21** Final Hearing on the proposed 2016 Budget and Tax Levy, aka Truth in Taxation hearing.

Scott Cordes, OFS, showed slides and said he was going to give a brief presentation on the budget and property tax as proposed for 2016. The Budget overall is proposed at \$546,000,000. That grew at about 3.5% over 2015. A lot of unique component is there are a lot of 1 time investments included. If you take out those 1 time investments, the growth rate is at 1.15% and 2.6% in the general fund. To describe those one time investments: the defeasance of paying down or buying off the debt service on Highland National Golf Course to \$4.8 Million, which is expected to save \$565,000 a year going forward. Leap year is in 2016; that one extra day costs the city about \$1.3 Million every four years. The maximum property tax levy is set at 1.9%. That is a total levy is 105.6 Million. Overall fees is \$151.5 Million. The expected burden is about \$43 with an increase over 2015. \$55 total all included. So, the property tax environment looks similar to 2015. Residential household are recovering the lost value during the recession. If you look at overall tax levies for the county, they came at 2.9%. Saint Paul's is 1.9%. Individual home owners and taxes are dictated by how taxes are shifted between properties. They have seen similar patterns as last year. Certain parts of the City grow faster than others. Those faster growing areas will see more taxes shifting toward those properties. The rest of the slides come forward from Ramsey County Property Records and Revenue. How property taxes are established, is a complex system in Minnesota. The City is responsibility for determining the levy, how much the total dollars the City will collect from taxpayers is established by the Levy, which is the City council's and Mayor's responsibility. The County Assessor determines what the property values are for each property. The state sets tax policy and how it is administered throughout the state, including setting the different property classes, rates, the levels of state aide, and levels of state business tax. There are resources included in the packet.

Brendmoen asked about links. When people's taxes jumped, they qualify for rebates from the state. Cordes responded that is available on the Ramsey County website.

Fern Ewasiuk states she went to the County meeting. She is a disabled tax person. No one at the meeting can believe hers went up so much. The head honcho is looking into it. Her husband makes money, and she is on a set income. She loves Saint Paul. This is disgusting. They have an undesignated back alley. They took her dirt. Her alley is totally washed away. Brendmoen responded they are still working on the alley and asked is it other neighbors, too. Fern responded it is only her. Most of the others are 16.9%.

Stark asked was her valuation changed.

(Her taxes were passed around.)

Fern said she shouldn't have an accessor come out when others have not.

Jerome Guetler, 1712 Dayton, stated the last ten years, the property taxes have gone up. The County accessor looked at it and said it was overassessed. It went down 11.2%. With a City that is fully developed, it is harder to raise more tax base. There is too much emphasis on value. It is set by the Legislature, but there doesn't seem to be enough voice. There are some people that have increases and some go down. When there is no possibility of gaining more tax revenue, you have to spread the burden out for more people. It has been a hardship that is hard to overcome. His only concern is when the City is overgrown, increase in spending, runaway cost. Stark responded a lot of property owners saw an increase. There is a shifting burden. Huge shift in taxes.

Guetler stated during the recession, my property values did not go down, but they still went up. The system does not work for mature cities like ours. It put too much burden on too few people. Stark responded they have a voice with the state. It is a statewide issue. Part of it is local control. For the most part, there are modest tax increases.

Fern stated she had a statement about hockey ice. The City paid a lot of money for that. There is not ice today. They are cutting Conway's ice. She is paying 92.3%

Marcia Moermond said this is about a fire certificate of occupancy orders which include the retaining wall be repaired or replaced. It is substantial.

Moermond said it is listing over the sidewalk. It has deteriorated. Huge sections are mortared over. The wall being out of plumb is a critical issue. The question is who is responsible. The wall is located on the boundary of the property at 332 Jessamine. The front of the wall, brick exists on the boundary and occasionally enters the public right of way. It was argument that the City constructed this wall. There is a section on the neighbor's. If the City didn't do it, then who did, is the argument. Whether or

not the City constructed it, it is the responsibility of the private property owner to maintain it. There is no permit going back this far. No permits were being issued for retaining walls. This would be in the bridge section of the Public Works. There is no record according to Kevin Nelson, Public Works. I don't think it matters if the City constructed it and she doesn't think it matters. The resolution says to deny the appeal and she would ask for October 1, 2016 for a deadline.

Councilmember Brendmoen said they have talked about this.

Robert Stein said a lot of things Moermond said are correct. (He showed an e-mail from the City) Stein said it is in some places 2 feet on the city's property. That is his first argument. These walls are all over the city of Saint Paul. It is odd.

(showed photos)

Brendmoen said this is a tremendous wall. What is the estimate. Stein responded \$40,000. Who back then would build this wall if it was not built by the City.

Brendmoen said there are walls like this all over the City. Stein responded he feels it is the City's responsibility.

Brendmoen said it is on the property's land. If it was built today, it would have to be pushed back.

Thune asked is it one long continuous wall? Stein responded it goes onto the neighbor's about 10%.

Moermond said the newer wall is another property. Stein responded the neighbors thought the City had filled in the stairs.

Thune said the City repaired it. Stein responded he does not have proof of that

Brendmoen said he will lay it over for two months to February 3. She cannot make a recommendation today. It is complicated and expensive. She would like an analysis. She does not understand why the City would repair part of the wall.
