## **CORRECTION NOTICE**

Dear Sir or Madam:

The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on **September 23, 2015** and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code<sup>1</sup> (see footnote 1, below).

- 1. <u>All vehicles must be correctly licensed, operable, secure from unauthorized entry,</u> and parked on an improved surface. Correct violations; store in a garage or remove.
- 2. <u>RESIDENTIAL PARKING ON UNAPPROVED SURFACE: All residential</u> <u>parking spaces shall be paved with asphalt, concrete or other suitable surfacing as</u> <u>determined by Zoning Enforcement. CEASE PARKING ON UNAPPROVED</u> <u>SURFACES. For information on installation of an approved parking surface</u> <u>contact Zoning Enforcement at 651.266-9008 regarding submittal and approval of a</u> <u>site plan.</u>

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will reinspect these premises on or after **September 29, 2015**, by which date the violations noted must be corrected. **Failure to correct these deficiencies may result in the issuance of criminal charges**<sup>2</sup> and/or a civil lawsuit, and possible abatement/assessment by the City. All repairs and new installations must be made in accordance with the appropriate codes. Permits may be obtained by calling 651-266-8989.

You may file an appeal to this notice by contacting the City Clerk at 651-266-8585. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal, and pay a filing fee.)
