Attached is a copy of the appeal I filed on March 2,2016 with the city of St Paul. The hearing is set for March 15 at 11:30 am. However, we would like to get started with our plans as soon as possible.

This is what we would like to review with you and get your input as to how we should approach this: Is a permit required to erect this type of structure, What city office should be contacted to move forward with this approach.


We have started the process of contacting architects/designers and approval/regulatory people to get a design of a permanent structure for the emergency egress from the second floor.






