Noise Source: HSR Events, Lowertown Blues Festival has applied for a sound level variance, with a sound level request of 92 dBA at 100 feet in order to provide music outdoors at Mears Park for an additional event date on Friday, July 22, 2016 from 12:00 p.m. until 5:00 p.m. for set up, and from 5:00 p.m. until 10:00 p.m. for the Event. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance shall be for Friday, July 22, 2016 from the hours of 12:00 p.m. to 5:00 p.m. for set up, and from 5:00 p.m. until 10:00 p.m. for the Event. 2) All electronically powered equipment used in conjunction with the event shall not exceed 80 dBA at 50 feet during the Event set up, and for the Event, from 5:00 p.m. until 10:00 p.m., 90 dBA as measured 50 feet from sound source. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 p.m. on the date of the event.
