# Sound Level Variance Application Twin Cities Jazz Festival Union Depot North Plaza

**Event:** Twin Cities Jazz Festival Union Depot North Plaza

**Locations:** Event will be located outdoors at Union Depot North Plaza

**Noise Source:** Twin Cities Jazz Festival has applied for a sound level variance in order to provide music outdoors at Union Depot North Plaza on Thursday, June 23, 2016 through Saturday, June 25, 2016, from 12:00 p.m. until 10:00 p.m., with a sound check at 12:00 Noon on Friday, June 24, 2016. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance shall be for the hours of 12:00 p.m. until 10:00 p.m. on June 23, 2016 through June 25, 2016, with a sound check at 12:00 Noon on Friday, June 24, 2016. 2) All electronically powered equipment used in conjunction with the event shall not exceed 80 dBA as measured at 50 feet from the sound source from 12:00 p.m. until 5:00 p.m. on June 23, 2016 and June 24, 2016, and shall not exceed 92 dBA as measured 50 feet from the sound source on June 23, 2016 and June 24, 2016 from 5:00 p.m. until 10:00 p.m. and on June 25, 2016 from 12:00 p.m. until 10:00 p.m. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 p.m. on the dates of the event.
