Noise Source: Kelly O'Shaughnessy has requested a sound level variance, at a requested sound level limit of 85 dBA at 50 feet in order to present amplified music with speakers from 6:00 p.m. until 11:00 p.m. for DJ birthday party music on June 25, 2016 at 702 Fairmount Avenue. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) Variance will be for amplified speaker music for the hours from 6:00 p.m. to 10:00 p.m. on Saturday, June 25, 2016. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 85 dBA at 50 feet from the noise source from 6:00 p.m. until 10:00 p.m. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 p.m. on Saturday, June 25, 2016.

If you attend the public hearing, you will be given the opportunity to present verbal comments or objections before the City Council.

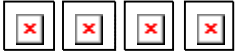
