Noise Source: Hmong Family Foundation, Inc., represented by Zue Lee and also Chia Koua Vang, 2016 Festival Coordinator, has requested a sound level variance in order to present amplified music and announcements during the Hmong Freedom Celebration 2016 at Como Park, McMurray Field Area, from 6:00 a.m. until 10:00 p.m. on Saturday, July 2, 2016 and Sunday, July 3, 2016. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance will only be for the hours of 9:00 a.m. until 8:00 p.m. on July 2 & 3, 2016. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 90 dBA as measured at 50 feet from any stage. 3) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the and equipment, who will conduct sound level monitoring during the event to ensure compliance with the variance conditions. 5) All electronically powered equipment, PA systems, loudspeakers or similar devices must be turned off no later than 8:00 p.m. on each event date.
