Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting scheduled on **Wednesday**, **July 6**, **2016** at **5**:30 p.m., in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse, 15 West Kellogg Boulevard, St. Paul, MN 55102.
