Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting scheduled on **Wednesday**, **July 20**, **2016 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse, 15 West Kellogg Boulevard, St. Paul, MN 55102.

Enclosed are copies of the resolution and supporting documents which will be presented to City Council for their consideration. This is an uncontested matter concerning the fact you were cited for 5<sup>th</sup> Degree Assault on May 18, 2015 in violation of Minn. Stat. §609.224.1 (Citation #620900266570). The incident you were cited for involved the assault of a female passenger while you were operating your taxicab. As the result of an Amended Plea, On February 26, 2016, you were convicted of Misdemeanor Disorderly Conduct – Offensive/Abusive/Noisy/Obscene in violation of Minn. Stat. § 609.72.1(3) in Ramsey County District Court. You were placed on Probation to the Court for a period of one (1) year which is scheduled to expire on February 26, 2017.

Due to the fact that the incident occurred inside of the taxicab, which is directly related to the licensed activity, the licensing office will recommend revocation of your license.

If there is any information you wish to present to the Council for their consideration before the public hearing, please send it to me no later than **Monday**, **July 11**, **2016**.
