Description of Variance

Location: Event will be located outdoors at the LaPlacita space, 193 Cesar Chavez Street (El Burrito Mercado)

Noise Source: El Burrito Mercado, Milissa Diaz, CEO/Director of Operations, has applied for a sound level variance, at a requested sound level of 85 dBA to 90 dBA at no specified distance in order to provide music and announcements outdoors at the LaPlacita space at 193 Cesar Chavez Street on eight (8) Sundays, July 31, 2016 through September 18, 2016 for the Fiesta Familiares Music Series. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) Variance will be for amplified music and announcements from 12:00 p.m. until 8:00 p.m. on eight (8) Sundays starting July 31, 2016 through September 18, 2016. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 85 dBA, as measured at 50 feet from the noise source from 12:00 p.m. until 8:00 p.m., with a two to four hour duration per event. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 8:00 p.m. on each event date.

If you attend the public hearing, you will be given the opportunity to present verbal comments or objections before the City Council.
