Location: Vandalia Tower Plaza, 550 Vandalia Street

Noise Source: The Summer Winter Studios LLC. has applied for a sound level variance, at a requested sound level limit of 105 decibels (dBA) at an unspecified distance from any stage or sound source, in order to present a live concert with amplified music. The Event is to be located at the Vandalia Tower Plaza, 550 Vandalia Street for the Summer Winter Summer Blowout on Saturday, August 6, 2016 from 3:00 p.m. until 10:00 p.m., with a pre-event sound check at 12:00 p.m. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance will be for the Summer Winter Summer Blowout Event on Saturday, August 6, 2016 from 3:00 p.m. to 10:00 p.m., with a pre-event sound check at 12:00 p.m. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 90 dBA as measured 50 feet from any stage or sound source from 3:00 p.m. until 10:00 p.m. , and 80 dBA at 50 feet from 12:00 p.m. until 3:00 p.m. on Saturday, August 6, 2016. 3) The applicant will provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices must be turned off no later than 10:00 p.m. on Saturday, August 6, 2016.
