Location: CHS Field, 360 Broadway Street North

Noise Source: Matt Kenevan, owner of Liquid 12 Festivals, DBA The Beer Dabbler has requested a sound level variance, at a requested sound level limit of 85 dBA at 50 feet from the sound source, in order to present live band amplified music with use of a public address system from 5:00 p.m. until 9:00 p.m., with a pre-event sound check at 3:00 p.m. on August 20, 2016 at CHS Field, 360 Broadway Street North. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) Variance will be for live band amplified music with use of a public address system for the hours of 5:00 p.m. to 9:00 p.m., with a pre-event sound check at 3:00 p.m. on Saturday, August 20, 2016 for the Summer Beer Dabbler Event. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 85 dBA at 50 feet from the noise source from 5:00 p.m. until 9:00 p.m. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 9:00 p.m. on Saturday, August 20, 2016.

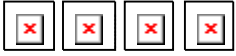
