Description of Variance:

Location: Harriet Island Park

Noise Source: Color Vibe has applied for a sound level variance, at a requested sound level limit of 90 dBA at 75 feet to provide announcements and music at Harriet Island for the Color Vibe 5K Event. The variance is requested for the hours of 7:00 to 11:00 a.m., with a pre-event sound check from 7:00 a.m. until 7:30 a.m. on Saturday, October 15, 2016. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 7:00 a.m. to 11:00 a.m. for the Event on Saturday, October 15, 2016. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured 75 feet from any sound source used for music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 11:00 a.m. on the date of the event.

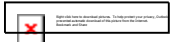

If you attend the public hearing, you will be given the opportunity to present verbal comments or objections before the City Council.

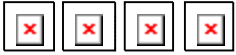
