On August 4<sup>th</sup>, I visited the site at 956 Geranium Ave E. I was able to view the foundation walls, and portions of the footing where some of the basement slab had been removed. I viewed the floor joists and much of the floor framing as well. There was obvious settling that has occurred with the existing structure. This can be stabilized with helical piers, and portions of the structure may be able to be jacked up to help bring it more level.

I have reviewed the helical pier design and report by Atlas Foundation. I understand soil borings have been taken and a soils report will be available. Upon my review of the soils report, I will determine the required quantity of helical piers necessary to properly support the foundation.
