### Retiree Gerald "Jerry" Tri passes away

Jerry Tri, a supervisor in water production maintenance who retired in 1988, passed away June 27 at the age of 83.

Jerry began working for the water utility in November of 1953 in the filter plant lab. In 1954 he became a junior filter plant operator and quickly moved from that position to an assistant filter plant operator and then a filter plant operator.

In 1963 he became a filter plant operator III, chang-

ing titles to filter plant operator II in 1970.

In 1985 he became a supervisor for water production maintenance, the title from which he retired in 1988.

Jerry worked for the utility for 35 years. He is survived by his wife Dolores and three children.

His funeral was Wednesday, July 6.


He is interred in the Fort Snelling National Cemetery with military honors.
