To Whom it May Concern:

We have been petitioning the neighborhood for a liquor license at Augustine's Bar and Bakery, located at 1668 Selby Avenue, St. Paul, MN, 55104.

In order to collect signatures and support for our liquor license, we put together a packet and sent it out to all address within 300 feet of our location. Each packet contained: a letter about our new restaurant and how we would like to have the neighborhood's support, a site map, and a self-addressed, stamped postcard.

- On July 14, we sent out 67 letters to all of the property owners; some owners account for multiple properties.
- On July 18, we started receiving our postcards back in the mail. We received 10 the first day, and at least one postcard each day since.
- On July 20th, I received a phone call from Daniel Dickenson(1669 Selby) with questions regarding our
 petition, our call concluded with him in favor of our petition, and even offering to speak with other
 neighbors on our behalf.
- On July 25th, we canvassed Selby and Hague around 6 pm. We spoke with 3 residents, all of whom
 favor our restaurant. Two signed the petition, one (1685 Selby) stated he supported our petition and
 had mailed his postcard, but we haven't received it yet.
- As of July 30, we have received back 34 postcards; some of these postcards represent more than one
 property in the area.
- We received 4 letters back as not deliverable: 1660 Hague is vacant and 1657 Selby has changed owners and the new owners signed the petition upon canvassing. 1676 Hague and 1664 Selby didn't respond to the foot canvassing either.
- On July 30 at 2 p.m., we canvassed the addresses that we had not yet heard from. We spoke with 5
 more people, 4 of whom signed the petition and expressed great enthusiasm for the project; the other
 person was not the home owner and we left a letter and postcard with them.

As of July 30, out of the 73 properties that we were assigned, we have secured approval from 44.We've attached the list of properties sent to us by the city, with annotations. (LiquorLicense1)

Also attached are the letter packet materials (LiquorLicensePacket1-3), the postcards we have received (LiquorLicensePostcards), and the sheets we used for canvassing with notations from whom we've received cards. Residents not home when canvassed are marked N/A. (LiquorLicense2)

On July 30, we mailed out a second batch of letters to the addresses that have not responded.

On the whole, we have encountered no one who opposes our patio plan or our request for a full liquor license. Every person we have spoken with is very excited about the addition to the neighborhood.

If there is any other information needed, please let us know what that is.
