Temporary Construction Easement

TEMPORARY CONSTRUCTION EASEMENT

THIS EASEMENT AGREEMENT is made this _____ day of ______, 2016, by and between the **City of Saint Paul**, a municipal corporation under the laws of the State of Minnesota ("Grantor"), and the **Metropolitan Council**, a public corporation and political subdivision of the State of Minnesota ("Grantee"), hereinafter collectively referred to as the "Parties."

NOW THEREFORE, for valuable consideration, the Parties agree as follows:

1. <u>Grant of Easements</u>. Grantor, the owner of the property described on the attached **Exhibit A** (the "City Property"), in consideration of One Dollar and other good and valuable consideration to it in hand paid, the receipt of which is hereby acknowledged, does hereby grant, bargain, sell and convey to Grantee, its permittees, successors and assigns, the following described easement:

Temporary Construction Easement

A temporary construction easement over, under and across the property legally described on the attached **Exhibit A** (the "Easement Area") for the location, installation, construction, repair, replacement, maintenance, use, and operation of a sewer interceptor and temporary meters (the "Temporary Construction Easement"). Said easement includes the right to perform any necessary restoration activities in the Easement Area as soon as possible following completion of construction activity, but no later than the expiration date of the easement term, as provided in Paragraph 2.

Grantee shall erect temporary fencing around the Easement Area and restrict all construction activity to within the fencing.

Subsequent to the commencement date of the Temporary Construction Easement as written below, and until its expiration date, Grantor, its heirs, successors and assigns, will not erect, construct, or create any building, improvement, obstruction, perpendicular utility crossing, or structure of any kind, either above or below the surface of the easement area or plant any trees, or stockpile construction debris or construction equipment, or change the grade thereof of the easement area without the express written permission of Grantee.

- 2. <u>Term of Temporary Construction Easement</u>. The Temporary Construction Easement shall commence on April 1, 2017 and expire on December 1, 2017.
- 3. <u>Restoration</u>. Grantee will ensure that following any construction activity by Grantee, the Easement Area will be restored as far as practicable to its previous condition.
- 4. <u>Covenant of Ownership</u>. Grantor covenants that it is the lawful owner and is in lawful possession of the City Property and has lawful right and authority to convey and grant the Temporary Construction Easement described herein.

5. <u>Notices and Demands</u>. All notices, requests, demands, consents, and other communications required or permitted under this Temporary easement shall be in writing and shall be deemed to have been duly and properly given three (3) business days after the date of mailing if deposited in a receptacle of the United States mail, first class postage prepaid, addressed to the intended recipient as follows:

TEMPORARY CONSTRUCTION EASEMENT

1. <u>Grant of Easements</u>. Grantor, the owner of the property described on the attached **Exhibit A** (the "City Property"), in consideration of One Dollar and other good and valuable consideration to it in hand paid, the receipt of which is hereby acknowledged, does hereby grant, bargain, sell and convey to Grantee, its permittees, successors and assigns, the following described easement:

Temporary Construction Easement

A temporary construction easement over, under and across the property legally described on the attached **Exhibit A** (the "Easement Area") for the location, installation, construction, repair, replacement, maintenance, use, and operation of a sewer interceptor and temporary meters (the "Temporary Construction Easement"). Said easement includes the right to perform any necessary restoration activities in the Easement Area as soon as possible following completion of construction activity, but no later than the expiration date of the easement term, as provided in Paragraph 2.

Grantee shall erect temporary fencing around the Easement Area and restrict all construction activity to within the fencing.

Subsequent to the commencement date of the Temporary Construction Easement as written below, and until its expiration date, Grantor, its heirs, successors and assigns, will not erect, construct, or create any building, improvement, obstruction, perpendicular utility crossing, or structure of any kind, either above or below the surface of the easement area or plant any trees, or stockpile construction debris or construction equipment, or change the grade thereof of the easement area without the express written permission of Grantee.

- 2. <u>Term of Temporary Construction Easement</u>. The Temporary Construction Easement shall commence on April 1, 2017 and expire on December 1, 2017.
- 3. <u>Restoration</u>. Grantee will ensure that following any construction activity by Grantee, the Easement Area will be restored as far as practicable to its previous condition.
- 4. <u>Covenant of Ownership</u>. Grantor covenants that it is the lawful owner and is in lawful possession of the City Property and has lawful right and authority to convey and grant the Temporary Construction Easement described herein.


