Your building was re-inspected for the Fire Certificate of Occupancy on July 27, 2016. Approval for occupancy will be granted upon compliance with the following deficiency list. The items on the list must be corrected immediately. A re-inspection will be made on September 15, 2016 at 1:30 PM.

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional re-inspection fees.

DEFICIENCY LIST

1. Exterior - Dwelling Roof - SPLC 34.09 (1) e, 34.32 (1) d - Provide and maintained the roof weather tight and free from defects.-
Shingles are curling and cracked on east and south side of roof.
Eave corners are gone on dwelling, eave boards need repair/replacement.
2. Exterior – Parking Spaces - SPLC 34.08 (7) - All parking spaces shall be paved with asphalt, concrete, or durable dustless surfacing. Before any existing spaces may be paved, site plan approval must be obtained as specified in the St. Paul Zoning Code. Contact DSI Zoning at 651-266-9090.-
Maintain surface for parking.

To whom it may concern:

We are filing an appeal on the above mentioned Inspection of July 27, 2016.

1. Exterior – Dwelling Roof
Bids to replace the roof have been obtained. The repairs to the roof are expensive and would create a financial hardship to complete by September 15, 2016. We are appealing this for additional time.
2. Exterior – Parking Spaces
We have pictures of other multi-family and single family homes in the area where there are unpaved (or paved in bad shape), or class 5 areas for parking. There is an asphalt area for parking with four spaces (two for each unit) available. Our tenants have always been compliant with this and have never complained. To replace this with asphalt by September 15th would also cause a financial hardship.

Due to the financial hardship of the costly repairs, we want to market the house and seek a party that would want to assume the repairs and remodel the duplex.
